Several scholars from five South Eastern European nations and Germany came together in March 2007 to discuss the basic legal structure on distribution of justice and contract law in their respective legal systems. The aim of the conference was the presentation and comparative discussion of national laws in the light of European harmonisation. The heterogeneous collection of compared countries - Germany and Greece being two long-time EU member states, Bulgaria and Rumania representing the two most recent members, and Turkey and the Ukraine standing as aspirants for future EU membership - proved itself unique and of corresponding interest.
