Nolon examines the effects of climate change on sea level and storm surges, examining local strategies for disaster preparation, mitigation, and recovery. He discusses the growing emphasis on green infrastructure and urban agriculture as crucial strategies for fostering a healthy environment and analyzes the role of environmental impact review. The book concludes with a discussion of environmental dispute resolution and consensus-based land use decision-making.
